Do With Your Personal Information?****Why?**

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also required us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

**What?**

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security Number and credit scores
- Income and assets
- Employment information and credit history

**How?**

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons First State Mortgage Services, LLC chooses to share; and whether you can limit the sharing.

What we do								
<b>How does First State Mortgage Services, LLC protect my personal information?</b>	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. <b>We also restrict access to nonpublic personal information about you to those employees that need to know the information to provide the products and services to you.</b>							
<b>How does First State Mortgage Services, LLC collect my personal information?</b>	We collect your personal information, for example when you <ul style="list-style-type: none"> <li>• Apply for a loan or give us your income information</li> <li>• Give us your employment history or show your government-issued ID</li> <li>• Provide account information</li> </ul> We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.							
<b>Why can't I limit all sharing?</b>	Federal law gives you the right to limit only <ul style="list-style-type: none"> <li>• Sharing for affiliates' everyday business purposes – information about your creditworthiness</li> <li>• Affiliates from using your information to market to you</li> <li>• Sharing for non-affiliates to market to you</li> </ul> State Laws and individual companies may give you additional rights to limit sharing.							
<b>What happens when I limit sharing for an account I hold jointly with someone else?</b>	Your choices will apply to everyone on your account							

Definitions	
<b>Affiliates</b>	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>• Our affiliates include financial companies such as Tri-County Financial Group, Inc., First State Bank and First State Insurance.</li> </ul>
<b>Non-Affiliates</b>	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>• First State Mortgage Services, LLC does not share with non-affiliates so they can market to you.</li> </ul>
<b>Joint Marketing</b>	<p>A formal agreement between non-affiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> <li>• First State Mortgage Services, LLC doesn't jointly market</li> </ul>

Other important information
<p>First State Mortgage Services, LLC complies with state privacy laws to the extent they apply.</p> <p><b>California</b> Residents: We will not share information we collect about you with non-affiliated third parties, except as permitted by California law, such as to process your transactions or to maintain your account. For <b>Nevada</b>: We are providing you this notice pursuant to state law.
